Terms and Conditions:

The Town of Sainte-Anne (Payee) has set out the following terms and conditions in regards to the Tax Instalment Payment Plan Services (TIPPS). The Registered Owner(s) (Payor) as listed on the application form, upon signing said application, agree to the following terms and conditions:

- 1. All withdrawals will be made on the 15th day of each month, except in cases where the 15th falls on a weekend or a holiday, then the withdrawal will be made on the next business day following the 15th;
- 2. The authorization for monthly withdrawals is continuing. The Payor(s) agrees to provide written notice (by letter or email) to the Payee, of any changes to banking or personal information, or to cancel participation in the TIPPS program by the 1st of the month;
- 3. The TIPPS program is from August 1st to July 31st. On the 15th of July, any amount left owing on the Payor's tax roll(s) will be automatically withdrawn from the Payor's account on that day;
- 4. Any application received after August 1st, a "catch up" payment will be required based on 12 months (August to July). Any applications received after December 1st may result in larger payments until July 31st of the next year, or may only start the following year on August 1st;
- 5. All prior outstanding tax balances must be paid in full prior to enrollment in the TIPPS program;
- 6. New charges of supplementary taxes and omitted assessment (for improvements or new construction) or outstanding charges added to the tax roll (throughout the year) are not included in the plan. **They must be paid** for as they become due.
- 7. No application fees are required to enroll in the TIPPS program;
- 8. Any payments withdrawn from the account that are dishonored by the Payor's Financial Institution by reason of non-sufficient funds, stop payment, account closed, etc. will result in an NSF fee be applied to the tax roll in accordance with the Town of Sainte-Anne Fees and Charges Policies and due and payable by the Payor. Will also result in the **immediate removal of the Payor from the TIPPS program**.
- 9. Each year on August 1st, the monthly withdrawals will be adjusted to reflect any increase in the municipal tax rate of that current year. If the Payor wishes have larger monthly withdrawals then the set amount, they may do so in writing to the Payee via email or letter.
- 10. The Payor authorizes the Payee, in accordance with the terms and conditions, to debit or cause to be debited, the Payor's banking account for the purposes of the TIPPS program.
